- I continue to advertise on Teach in Nebraska website seeking a Music Instructor beginning with the 2025-2026 school year. Various combinations of vocal and instrumental courses and levels will be considered based on student needs and strengths of the candidate. - Dish Machine survived one more repair with a motor replacement. I believe it will last at least until December. Having said that, I will try the equipment grant again this fall.
