BOARD OF EDUCATION BUDGET HEARING AND REGULAR MEETING

St. Edward School Science Room – St. Edward, Nebraska Monday, September 8, 2025, 6:30 p.m.

The St. Edward Public School Board of Education conducted a budget hearing with the regular September meeting immediately following the budget hearing, on Monday, September 8, 2025 at the schoolhouse. Advance notice of the meetings was published in The Albion News & Boone County Tribune on August 27, 2025, and posted in the school's main office along with the agenda for the purpose of hearing support, opposition, criticism, suggestions or observations of taxpayers relating to the proposed budget. The budget details were available at the office of the Superintendent during regular business hours.

1. Opening Procedures:

- a. The budget hearing was called to order by President Roberts at 6:40 p.m. with members Merrell, Reardon, Cumming and Cruise, present. Also in attendance were Steve Osborn, Lindsay Tenski and Tyler Gray
- b. Pledge of Allegiance
 Motion made by Roberts seconded by Cumming to excuse Christman from the Budget Hearing.
 Roll call vote: Reardon-Yea, Roberts-Yea, Cruise-Yea, Merrell- Yea, Cumming- Yea:
 Motion carried 5-0.
- a. President Roberts stated the hearing will follow the Open Meetings Act, which is located in the meeting room.
- b. The purpose of hearing was to hear support, opposition, criticism, suggestions or observations of taxpayers relating to the proposed budget and to consider amendments relative thereto.
- c. Mr. Osborn presented the proposed budget to the board of education and patrons. The proposed operating budget sets the General Fund at \$5,299,606.00, Depreciation Fund at \$65,652.00, Activity Fund at \$274,353.00, School Nutrition Fund at \$243,000.00, and the Special Building Fund at \$358,124.00. Of these funds, the two that are supported by tax asking requests are the General Fund and the Special Building Fund. This is an increase in the General Fund operating budget of 4.0%. The main increase in General Fund expenditures is for increase in salaries and benefits, curriculum adoption, vehicle acquisition, and cost to maintain the building. The increase in the operating budget of Special Building Fund of 16.0% is due to the purchase and installation of our new preschool playground equipment. The board is committed to the effort maintaining the Special Building Fund in preparation for necessary site improvements such as our main entry door replacement project last year as well as the possibility of needing to address unexpected expenses. There will be no action on the budget at this meeting as we will be attending the Joint Public Hearing on September 22, 2025 at the Boone County Court House. There will be a special meeting for the approval of the budget to be scheduled following the hearing process.
- d. The budget hearing adjourned at 6:54 p.m. by executive order.
